It is GOL Single-member LLP's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to <https://www.alfortino.com> (hereinafter, "us", "we", or "alfortino.com"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

## **Website Visitors**

Like most website operators, GOL Single-member LLP collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. GOL Single-member LLP's purpose in collecting non-personally identifying information is to better understand how GOL Single-member LLP's visitors use its website. From time to time, GOL Single-member LLP may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

GOL Single-member LLP also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on <http://alfortino.com> blog posts. GOL Single-member LLP only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

## **Gathering of Personally-Identifying Information**

## **Alfortino.com uses Google AdWords for remarketing**

Alfortino.com uses the remarketing services to advertise on third party websites (including Google) to previous visitors to our site. ## **Protection of Certain Personally-Identifying Information**

GOL Single-member LLP discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on GOL Single-member LLP's behalf or to provide services available at GOL Single-member LLP's website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using GOL Single-member LLP's website, you consent to the transfer of such information to them. GOL Single-member LLP will not rent or sell potentially personally-identifying and personally-identifying information to anyone.
